

Ken Griffey Jr.'s MLB Trivia Official Rules

Promotion Overview:

This Promotion includes an “Instant Win Game” and a “Sweepstakes.”

Eligibility:

Ken Griffey Jr.'s MLB Trivia (the “Promotion”) is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years old at the time of entry. To receive prizes valued at \$2,000 or more, entrant must be able to submit a valid IRS Form W-9. Employees of BlueTriton Brands, Inc. (“Sponsor”), MLB Entities, Merkle Inc. Agreement to Official Rules; Entrants Will Be Disqualified for Violations:

Participation constitutes entrant’s full and unconditional agreement to these Official Rules. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Timing:

The Promotion begins on May 1, 2026 at 12:00 a.m. Eastern Time (“ET”) and ends on October 31, 2026 at 11:59 p.m. ET (the "Promotion Period"). How to Register; Receive Sweepstakes Entry and Receive Instant Win Game Play:

During the Promotion Period, visit baseball-trivia.com (“Promotion Site”) and follow the links and instructions to answer the daily trivia question. Next, accurately complete and submit the registration form, including your first and last name (initials are not sufficient), email address and select from the drop down your favorite water brand. If you are a current Rewards Drop® member, register using the email address associated with your Rewards Drop® account. You will receive 1 entry into all open Entry Periods and 1 play for the Instant Win Game, regardless of whether your answer to the daily trivia question is correct. Sweepstakes:

Administrator will randomly select the potential Sweepstakes winners from all eligible entries received for the applicable Entry Period on or around the dates set forth in the table in the Timing section above and will notify potential winners by email. Instant Win Game:

There will be 150,625 random, computer-generated winning times seeded throughout the Promotion Period, one for each Instant Win prize offered. If you are the first player to play the Instant Win Game at or after one of the randomly-seeded times, you will be a potential instant winner of the prize indicated, subject to verification of potential winner's eligibility. Potential Winners Subject to Verification:

General Conditions:

Sponsor's Right to Modify or Cancel:

Sponsor reserves the right to cancel, suspend and/or modify the Promotion, including but not limited to fulfillment of the prize(s), where any of the following "Issues" occur:

- Fraud
- Technical failures;
- Human error;
- Any other factor that impairs the integrity or proper functioning of the Promotion; or
